Delaware Pro-Life Hero: Donna Latteri

Donna Latteri got involved in the pro-life movement back in 1989 when she became а single mom. "Thanksgiving day, 1989, I had my son Jonathan. It is because of him that I am now committed to the pro-life movement. Jonathan gave me my only grandson! Truth is, abortion kills for generations! God changes people through circumstances, and when I became a single mom, my heart changed; I just knew that I had to start helping people." She knew she had to help stop abortion.

She started looking for opportunities, but there weren't that many where she lived in Sussex County, New Jersey. When she moved to Delaware in 2009, she saw a notice in her church bulletin looking for pro-life volunteers. "I found out more," she says, "and I got involved right away."

For many years, she says, Jim Cordie was the "main guy" in Sussex and Kent County. When he had to step back, "He kind of turned things over to me...so, I just started doing things on my own." She coordinates the 40 Days for Life, twice a year.

Especially meaningful for her is the National Day of Remembrance for Aborted Children, a memorial prayer service for the unborn at Holy Cross Cemetery. "We've had

as many as 50 people attend. My goal has been for the past few years to get post-abortive mothers to attend." They pray for each child by name. "We remember the children through our prayers and our singing. It's actually a very healing service for a lot of the moms." She says she also has "amazing memories" of talking to fathers who didn't support their child's abortion who ended up crying on her shoulder while she gave them a hug. That happens "on the sidewalk at Planned Parenthood. We touch so many hearts out there."

She recalls the times when she was able to save babies from abortion. A few months ago, she remembers, "a lady came up to us and gave us hugs. She said her sister was inside the Dover abortion facility, saw us out there, and walked out. Her baby's almost a year old now." Another time, she recalls, "while we were out on the sidewalk on a hot day a big, burly guy came up with these big arms sporting a tattoo with baby feet. He said he and his girlfriend were in the Dover facility, saw us on the sidewalk and, realizing 'they weren't raised that way,' got up and walked out! How many babies will we meet when we die that we didn't know we saved!"

"Being an advocate for the mothers is critical for me," says Latteri, getting them the "help and assistance they need." There was one girl who took the pill–"I couldn't talk her out of it, but being there for her all weekend, letting her know God loves her, being the face and patience and love of God, that's what really mattered. *Cont. on p.3*

Cont. from p. 2 She told me later on, 'You couldn't save my first baby, but you saved my next baby.' She did get pregnant again. She did keep her baby and we still keep in touch. Every October 14th I remember her because her heart is breaking."

She says that, when she's talking to people about abortion, "Instead of telling them a lot of information, I ask them a lot of questions and I guide the conversation. By asking them a lot of questions, peeling back the onions, peel by peel, you eventually get to what the real issue is. Then they feel better, building trust so you can start to help them from there."

Going forward, her message to others would be

that "abortion is not love," a quote from Dr. Bernard Nathanson, (the "King of Abortion") who, Latteri says, stopped doing abortions when he saw an ultrasound of the unborn baby screaming and trying to get away from the device.

She also says, "We need to recognize the child as human, deserving of all rights. No matter where you are in life, God loves you. We need to see people where they're at, like the woman at the well. We need to meet them where they're at, not with judgmental eyes, which is so easy to do. We need to lend an ear and be a resource for them, so

they have courage, and gain the inner strength to get through whatever it is they need to get through."

What's in Our Drinking Water?

It is highly recommended that everyone educate themselves on the issue of abortion pills and human remains (biohazardous waste) in our water systems. *http://www.abortioninourwater.org* website from Crosstalk podcast is a good starting point. The experts interviewed are from Liberty Council Action—a biblical worldview ministry. Abigail Forman is Director of Policy for the Right to Life UK and the primary author of the White Paper which includes the following key points:

- 1. The breakdown of Mifepristone results in metabolites that are classified as endocrine disruptors thus blocking progesterone. This is a concern for lowered fertility rates as well as cancer. We are not testing our water at present for the drug.
- 2. Human waste (sadly 30-40 tons) a year estimated is not tested for at water treatment centers resultant in fetal biomarkers in the drinking water.
- No research studies were conducted for the environmental impact of the drugs and medical waste from abortion pills before the drugs were FDA Approved.
- 4. Violations apparent from the Clean Water Act, EPA and FDA

They perform ultrasounds, pregnancy tests and also provide new moms with access to the baby boutique. In 2021 they served 127 clients... they are now seeing over 60 every month! A 5X increase!! Britnee feels "honored to be on this mission battlefield".

Bill to Defund PP Now Law—or Is It?

Trump's "One Big Beautiful Bill," signed into law on July 4th, contains provisions that eliminate Medicaid funding for Planned Parenthood for one year, not the ten years called for in the original version. Abortion providers are upset and many others are confused as to what the new law will accomplish.

Restrictions to prevent federal funds from being used for Planned Parenthood's abortions already exist (Hyde amendment), but this new bill would restrict the organization not just from getting any federal funds, but also state-run Medicaid funds. Medicaid, although it does use some federal funds, allows states to allocate their own funds to abortion if they wish. Because of this loophole, there are some states that allow funds to be used for abortion, even though federal funds are restricted from covering it. The Big Beautiful Bill would eliminate that exemption.

Delaware's status is unclear because according to Planned Parenthood of Delaware, abortion is not covered by Medicaid, however, according to <u>abortionfunds.org</u>, Delaware *does* cover it. It is among the 19 states listed as allowing Medicaid funds to pay for abortion. In addition, the Delaware Health and Social Services website says that women may be eligible for Medicaid for "birth control and *family planning services* for up to 24 months after their regular Medicaid stops [emphasis added]." (<u>https://dhss.delaware.gov/</u> dmma/medicaid/)

Pro-choice news outlets argue that, because abortion is already not funded by the government (a lie), all the bill will do is restrict Medicaid funding from Planned Parenthood services like STD testing and birth control. Simple research reveals that Planned Parenthood *is* paid for by Medicaid, and those abortions would be defunded by the Big Beautiful Bill, if it holds up in the courts – one judge, Indira Talwani, issued a ruling on July 7 that blocks the PP defunding portion of the bill. Another drawback are the exceptions written into it that create loopholes for life and health of the mother, rape, incest, and fetal anomaly.

The battle to restore rights to the preborn is ongoing and takes constant vigilance.
