## Board Business Jeanette Betancourt

When the Open Meeting resumed, Ms. Betancourt introduced Ellen Quish, a parent of an OWN alumnus who has expressed interest in serving on the Board. She also confirmed the continued interest of Manu Bhagavan, and it was agreed that both candidates should be interviewed.

Ms. Betancourt also reported out on the very positive Strategic Planning meeting held in early October, which she described as decisive and productive. She also noted the need to schedule a follow-on meeting. It was agreed we would aim to schedule the meeting to support the replication application process.

## Finance & Administration Committee Maura Fitzgerald and Karrine Montaque

Ms. Fitzgerald reported on the Finance Committee meeting held in November which focused on a careful review of the health insurance quotes solicited by the business office. With input from the Committee the Administration has decided to enter into a new PEO (Professional Employer Organization) relationship with Extensis which will result in significant savings and provide support for benefits compliance. They are still reviewing options for employee cost sharing of premiums.

In light of the time spent reviewing benefits, the Committee did not review the 1<sup>st</sup> Quarter Financials, but Ms. Montaque reported that there were no substantial variations in actuals vs budgeted figures at the end of the first Quarter, except for the lower per pupil income due to lower enrollment which has been previously discussed.

Ms. Montaque noted progress made on the enrollment front: the Kindergarten is full, and we've admitted a few new first and second graders. The Board reiterated its interest in developing and refining our branding and messaging to set OWN apart from some of the other school options that have emerged in district 30 since the school originally opened. Mr. Crusante reminded the Board that there is a new marketing video in progress and said he expected to have a rough cut for review by the Development Committee by December. The Board also encouraged the Administration to consider strategies for a) overenrollment to anticipate attrition; and b) developing more marketing pieces that highlight all the arts, science and sports activities we offer our students, and pushing those communications pieces out instead of waiting for people to visit our website. It was agreed that this is such an important topic that it requires a thorough analysis, and a special session at one of our upcoming meetings, therefore the Board interested parties to convene a half hour before our next regularly scheduled meeting.

## Development Committee Jeanette Betancourt

Ms. Betancourt reported that the Development office is finalizing a grant request for \$40K to support health and wellness programs. They also met with the Peter Carmen

Lucia Buck foundation and learned about their plans for realigning funding priorities that may dovetail with our replication plans. Mr. Crusante also attended a meeting regarding the 21<sup>st</sup> Century Learning Center grant, but there is still no word about whether it will be extended.

Members of the Board were encouraged to make their annual donation.

# Facilities Committee Rich Bogle

Mr. Bogle shared a timeline developed with the Business Office and the Treasurer to jump start progress on the Lifetime building project that is fully integrated with planning for a replication of OWN, and defines key questions to be answered with the support of a consultant over the next several months.

# Education Committee Sarah Espanol

Ms. Espanol reported on the Committee meeting which focused on an analysis of data from ELL testing to inform a cohesive action plan. They explored areas of weakness and how to adjust the curriculum, and structure coaching accordingly to help our students meet the standards.

In the meantime, former Elementary School teacher Leslie Rossello is revising the Social Studies and Science curricula to integrate inquiry-based learning to develop critical thinking skills. When the work is further along, they will report back.

#### PTO

## Sarah Espanol

Ms. Espanol, who is a former PTO co-chair and who still helps organize the annual auction reported that it was a tremendous success. It exceeded last year's income raising between \$13-14K. Several board members attended along with OWN staff. They had an excellent time and thanked all those who contributed to making the evening a success.

She noted that there was a clean-up at "Bear Park" near the Elementary School on Saturday and that many parents and kids were very helpful. The City is planning to update the park and will seek community input.

Ms. Edmiston reminded the Board that the school play, Guys & Dolls Junior will be held on December 10<sup>th</sup> and 11<sup>th</sup>
